IN FY18, OUR NETWORK OF 2,200 AGENTS IN THE COMMUNITY AGENT NETWORK PROGRAM IN THE PHILIPPINES FACILITATED TRANSACTIONS WORTH MORE THAN US\$25.7 MILLION FOR 1,591,890 CUSTOMERS (75 PERCENT OF THE AGENTS ARE WOMEN).
